



1. PARTIES

This agreement is made between:

Stichting The Wormhole Cult, a non-profit foundation registered in the Netherlands (hereinafter referred to as the "Promoter"),

and

Artist / Band Name, represented by (hereinafter referred to as the "Artist").

These Terms & Conditions apply to all performances organised or promoted by the Promoter, unless otherwise agreed in writing.

2. PERFORMANCE

2.1 Date, Time and Venue

The Artist agrees to perform on (date) at (Venue name) at the agreed time(s).

2.2 Nature of Performance

The Artist shall provide a professional live music performance consistent with their artistic practice, agreed set length and line-up.

2.3 Technical Rider

Technical requirements (sound, lighting, backline and stage setup) shall be agreed in advance via a technical rider. Responsibilities for providing equipment will be clearly specified therein.

3. FEE AND PAYMENT

3.1 Performance Fee

The Artist shall receive a total fee of € , unless otherwise agreed.

Payment will be made as follows:

3.2 Merchandise

The Artist is entitled to sell merchandise at the event and shall retain 100% of the merchandise income, unless explicitly agreed otherwise in writing.





4. PROMOTION

4.1 Promotion of the Event

The Promoter will promote the event through its usual channels.

4.2 Promotional Use of Artist Materials

The Artist grants the Promoter permission to use the Artist's name, biography, images and logos for promotional purposes related to the event.

5. CANCELLATION

5.1 Cancellation by Promoter

If the Promoter cancels the event more than 30 days prior to the performance date, no fee shall be due.

If cancellation occurs within 30 days, the Promoter and Artist will seek a fair and reasonable solution, taking into account already incurred costs.

5.2 Cancellation by Artist

If the Artist must cancel due to serious illness, emergency or force majeure, the Artist shall inform the Promoter as soon as reasonably possible. Both parties will make reasonable efforts to reschedule.

6. TRAVEL AND ACCOMMODATION

Unless explicitly agreed otherwise, the Artist is responsible for their own travel and accommodation expenses.

Any hospitality arrangements (such as meals or drinks) shall be agreed in advance.

7. LIABILITY AND INSURANCE

7.1 Permits and Event Insurance

The Promoter is responsible for obtaining appropriate event permits and public liability insurance.

7.2 Artist Equipment and Personal Insurance

The Artist is responsible for their own instruments, equipment and personal insurance.

7.3 Limitation of Liability

Neither party shall be liable for indirect or consequential damages, except in cases of wilful misconduct or gross negligence.





8. RECORDING AND RIGHTS

8.1 Ownership of Performance Rights

All intellectual property rights in the performance remain with the Artist.

8.2 Use of Short Recordings and Photographs

The Promoter may take and use short audio-visual recordings or photographs for non-commercial promotional purposes, provided the Artist is credited.

8.3 Consent for Full Recordings and Commercial Use

Full recordings, livestreams or commercial use require prior written consent of the Artist.

9. FORCE MAJEURE

Neither party shall be held liable for failure to perform obligations due to circumstances beyond reasonable control, including but not limited to natural disasters, government restrictions or public safety concerns.

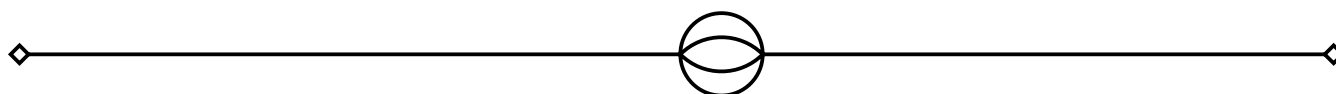
10. GOVERNING LAW
