



1. PARTIES

These Terms & Conditions are entered into between:

Stichting The Wormhole Cult, a non-profit foundation registered in the Netherlands (hereinafter referred to as the "Promoter"),

and

.....(venue name), located at(address)
represented by(name) (hereinafter referred to as the "Venue").

These Terms & Conditions apply to all concerts and events organised or promoted by the Promoter at the Venue, unless otherwise agreed in writing.

2. EVENT DETAILS

2.1 Date and Time

The concert shall take place on [date] at [venue], at mutually agreed times for load-in, soundcheck, doors, performance and curfew.

2.2 Use of Venue

The Venue makes available its premises for the purpose of hosting a live music event promoted by the Promoter.

3. RESPONSIBILITIES OF THE VENUE

The Venue is responsible for:

- Providing a safe, clean and properly maintained space suitable for live performances;
- Complying with all applicable laws, permits and regulations, including noise, safety and capacity regulations;
- Providing agreed technical facilities (PA, lighting, stage, basic backline if applicable);
- Ensuring qualified technical staff is present where required;
- Providing basic hospitality for artists as agreed in advance.

4. RESPONSIBILITIES OF THE PROMOTER

The Promoter is responsible for:

- Booking and contracting the artists;
- Promotion and marketing of the event;
- Managing ticket sales, unless otherwise agreed;
- Coordinating the event schedule in consultation with the Venue;
- Paying the agreed venue fee or revenue share, if applicable.



5. FINANCIAL ARRANGEMENTS

5.1 Venue Fee / Revenue Share

The financial arrangement for each event shall be agreed separately and may consist of: - a fixed venue fee; or - a percentage-based revenue share; or - another mutually agreed structure.

5.2 Settlement

Settlement of ticket revenue and/or venue fees shall take place within [number] days after the event, unless agreed otherwise in writing.

6. TICKETING AND CAPACITY

6.1 Communication of Maximum Audience Capacity

The Venue shall clearly communicate the maximum legal audience capacity.

6.2 Compliance with Capacity Limits

The Promoter agrees not to exceed this capacity in ticket sales.

6.3 Door Control and Audience Safety

The Venue shall ensure proper door control and audience safety during the event.

7. PROMOTION AND BRANDING

7.1 Use of Venue Name and Materials

The Venue grants the Promoter permission to use the Venue's name, logo and images for event promotion.

7.2 Venue Credit in Promotional Materials

The Promoter will credit the Venue appropriately in promotional materials.

8. RECORDING AND MEDIA

Any audio or audiovisual recording, livestreaming or broadcasting of the event requires mutual consent of the Promoter and the Venue, as well as the performing artists.

9. CANCELLATION

9.1 Cancellation by Promoter

If the Promoter cancels the event in a timely manner, the parties will make reasonable efforts to reschedule or reach a fair settlement.





9.2 Cancellation by Venue

If the Venue cancels the event without force majeure, the Venue shall compensate the Promoter for reasonable and demonstrable costs already incurred.

10. LIABILITY AND INSURANCE

10.1 Venue Public Liability Insurance

The Venue is responsible for appropriate public liability insurance covering the premises and audience.

10.2 Responsibility for Equipment, Staff and Insurance

Each party remains responsible for its own equipment, staff and insurance.

10.3 Limitation of Liability

Neither party shall be liable for indirect or consequential damages, except in cases of wilful misconduct or gross negligence.

11. FORCE MAJEURE

Neither party shall be held liable for failure to perform due to circumstances beyond reasonable control, including but not limited to government measures, severe weather or public safety concerns.

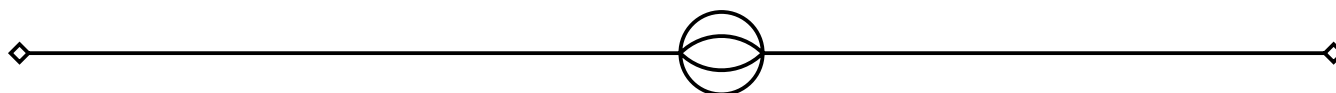
12. GOVERNING LAW
